WHEREAS, the Onondaga Central School District (the "District"), is a local agency pursuant to the New York State Environmental Quality Review Act ("SEQRA"), ECL Section 8-0101, et seq., and implementing regulations, 6 NYCRR Part 617 (the "Regulations"); and

WHEREAS, the District is considering undertaking a capital improvement project consisting of renovations and improvements to the Rockwell and Wheeler Elementary Schools, Junior/Senior High School, Industrial Arts Facility, Transportation Facility, District Office and Technology Office including, for each, site improvements, original furnishings, fixtures and equipment and energy efficiency improvements (the "Project"); and

WHEREAS, the District's Board of Education considered the Project in light of the actions included on the Type I and Type II lists set forth under the Regulations at sections 617.4 and 617.5, respectively, and concluded by resolution adopted December 13, 2016 that the Project is a Type II Action as defined under SEQRA and therefore is not subject to review under SEQRA because the Project involves "maintenance or repair involving no substantial changes in an existing structure or facility" (Section 617.5(c)(1)), the "replacement, rehabilitation or reconstruction of a structure or facility, in kind, on the same site" (Section 617.5(c)(2)), and "routine activities of educational institutions, including expansion of existing facilities by less than 10,000 square feet of gross floor area" (Section 617.5(c)(8)).
