May 8 - 15, 2024	Budget notice must be mailed to eligible voters after the budget hearing but no later than six days prior to the vote.
May 15 - 20, 2024	District clerk must maintain a list of names of those residents who were given absentee ballots and make such list available for public inspection the five days prior to the annual meeting except Sunday. (Public posting no longer required)
May 16-20, 2024	Sworn statements of campaign contributions or loans in excess of \$1,000, received before vote date and not previously reported, to be filed with the District Clerk and Commissioner of Education within twenty-four hours of receipt by candidates for membership on the Board of Education.
May 20, 2024	Last day in-person absentee ballots may be received by the district clerk.
May 21, 2024	Board of Education Meeting Statewide annual meeting/board election/budget vote day (7 am – 9 pm) Email budget vote results to press.
June 10, 2024	Last date to file with District Clerk and Commissioner of Education final sworn statement of campaign contributions by candidates for membership on Board of Education.
June 18, 2024	Statewide budget revote day
July 1, 2024	Implement 2024-25 Budget
